



#### **Our Community**

**Before the COVID-19 pandemic, 50 percent of Broward County** households were the ALICE population (Asset Limited, **Income Constrained, Employed)** or living below the federal poverty level - working hard but falling short.

In February 2020, the unemployment rate in Broward County was 2.9%, but by May 2020, it was a high of 15.2%. This highly increased the needs for assistance with food, rent/mortgage, utilities and more.

#### **You Helped Her Family - Twice**

"I moved to Broward County from Venezuela, married my husband and had our beautiful daughter, Valerie. We were excited about our future. My husband luckily was employed, but without any family nearby to take care of our daughter, I was unable to work. I didn't know what to do," says Cecilmar, 'I didn't know anyone else."

Not knowing what to do next, Cecilmar was relieved to learn about a United Way of Broward County-funded program, Center for Working Families. First, she received financial assistance for childcare so her daughter could be placed in a safe early learning environment. With her daughter taken care of, Cecilmar was now able to attend a job readiness workshop, learn resume and interviewing skills, and meet with an employment coach. Eventually, she secured a position as an insurance agent. She also continued to meet with a financial coach to learn budgeting, as well as how to reduce debt and improve her credit.

Cecilmar and her husband were making great strides toward financial freedom until the COVID-19 pandemic caused her to lose her job in April 2020. "Fortunately, the Center for Working Families was there to help again," she says. Through United Way of Broward County's funding, she received help buying groceries and household items, while SNAP and Medicaid helped her access food

Although there have been bumps in the road, Cecilmar is optimistic about the future. As her family continues to receive support, she is currently training to become certified to help others access healthcare through ACA. "I am so grateful for the assistance – especially to United Way of Broward County and the Center for Working

and medical resources without straining her budget.

Families," she says.

The Center for Working Families (CFW) is a partnership with Hispanic Unity of South Florida, Urban League of Broward County, Arc Broward and United Way of Broward County. CFW helps low-income families reach financial stability. The CWF approach brings together - or bundles - access to a full range of essential economic supports, including income enhancement and work supports, employment services, and asset-building services in one convenient location to help families build self-sufficiency, stabilize their finances and move up the economic ladder. This model teaches clients to "Earn It," "Keep It" and "Grow It."

## Tranks to you we're making

#### Helping children learn to read at grade level

Until the pandemic closed schools, United Way of Broward County's ReadingPals initiative operated in 23 schools with one-on-one reading mentorship, and then went virtual:

**400** students in pre-K through second grade had a ReadingPal.

**16,333** books were distributed to students.

**100%** of teachers felt ReadingPals was a positive experience for their students.

Currently, ReadingPals is operating online with virtual learning and e-books in 17 elementary schools and three childcare centers, leaving 121 public elementary schools without this invaluable support for students and parents.

#### **Providing Veterans the support they have earned**

Through MISSION UNITED, United Way of Broward County's supportive services for Veterans initiative:

**1,539** Veterans received pro bono legal assistance.

**829** Veterans were connected to housing support.

**766** Veterans received financial support.

Still, there is a great need to expand these services so all Veterans have the support they have earned.

#### **Empowering people to earn, keep and grow assets**

Of those served by United Way of Broward County's financial stability programs:

**91%** were able to increase their self-sufficiency through employment stability.

**93%** increased their level of self-sufficiency with housing support.

**100%** who worked toward increasing their credit scores accomplished their goal.

Prior to the pandemic, 50% of households in Broward County were Asset Limited, Income Constrained and Employed (ALICE) or living below the poverty line. Countless more households have been affected by wage losses and instability due to COVID-19 so the need is even greater.



#### ng a difference every day throughout our community

#### Providing access to fresh, nutritious food

**Through United Way of Broward County's Project Lifeline program:** 

- **687,721** individuals and families were served.
- **2.3** million pounds of nutritious food were distributed.
- **25** local food banks distributed until the pandemic forced some closings.
- Still, the pandemic greatly increased the number of people without access to food due to wage losses, quarantines and isolation.





#### Helping children, youth and families live substance-free

Through United Way of Broward County's Commission on Behavioral Health & Drug Prevention:

- **1,030,541** people were exposed to positive messaging and programming related to substance use prevention and behavioral health promotion.
- **92%** of youth increased their positive attitudes in abstaining from substance use.
- **87%** of parents who were educated on substance use reported an increase in parenting skills.
- > Still, 41% of Broward County high school students have used electronic cigarettes (vaping).

#### Providing opportunities for people to achieve optimal health

Of those supported by United Way of Broward County's health programs:

- **3,522** children received dental hygiene services.
- **88%** increased their knowledge regarding health.
- **94%** of participants felt they increased their number of healthy days.
- ▶ However, from March to October 2020, more than 32% of all calls to the 2-1-1 Broward helpline were for assistance relating to risk for suicide and mental health issues. Only the number of requests for financial assistance was greater.



### Responding to emerging needs during the COVID-19 pandemic while also doing our year-round work

Funded 41 local organizations and programs to support the community during COVID-19

### \$1,066,993

in emergency financial assistance was distributed for basic needs like rent/mortgage, utilities, household supplies, gas/public transportation, etc.

meals were delivered to homebound seniors, Veterans, homeless individuals and hardworking, low-income families \$401,128

in assistance was provided to partner agencies to help hungry individuals and families purchase food


